The staff mentioned above has been sanctioned to initiate academic / patient care / other services in the newly proposed medical colleges using the existing ESIC hospitals. The existing staff sanction of these hospitals will remain in place to ensure the uninterrupted provision of patient care services.

The rationalization of staff sanctioned separately for hospital and medical college will be communicated by ESIC Hqrs, based on the developmental stage of the medical colleges.

To optimize the utilization of manpower, the respective Deans and Medical Superintendents are directed to hire contractual and outsourced staff as per actual requirement basis considering the combined needs of both the college and hospital. The sanction given for contractual and outsource staff is upper ceiling and the engagement shall never overshoot the specified number.

Further, the Deans and Medical Superintendents are also instructed to rationalize the staff approved separately for Hospital and Medical College at their own level wherever feasible ensuring compliance with NMC regulations without compromising delivery of medical services. All contractual and outsource staff engagement shall be duly concurred by local finance considering academic/ NMC requirements, bed occupancy, actual workload, local incidences and other issues.

The Regular Recruitment against the posts for which RRs are yet to be framed will be done after finalization of RRs for these posts.

The Finance Division has accorded their concurrence vide their note #110 of the e-file of bearing L-11/12/3/NEWESICMEDICALCOLLEGE/2024-MEC.
